



# BOULEVARD AT BOX HILL RAVENS' SWEEPSTAKES

## Sweepstakes/Contest Rules and Policy

### Eligibility

Boulevard at Box Hill's Ravens' Sweepstakes Sweepstakes (the Contest) is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Entrant must be present to win. Employees of University Center and other companies associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

### Sponsor

### Agreement to Official Rules

Participation in the Sweepstakes constitutes entrants full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

### Contest Period

The Contest begins on October 5, 2018 at 6:00pm EST and ends on October, 5 2018 at 8:00pm EST (the Contest Period). Entries that are submitted before or after the Contest Period will be disqualified. Submissions will be accepted for the duration of the Contest using any of the following methods: On-Site only - MUST BE PRESENT TO WIN.

### How to Enter

On-Site: This method of entry will be available at Boulevard at Box Hill, Sunsets on the Boulevard Concert, 3459 Merchant Blvd, Abingdon, Maryland 21009.

Limit one (1) entry per person, per email for the duration of the Sweepstakes Period, regardless of method of entry. Entries received from any person or email, in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

### Prize Drawing

On October 5, 2018, the Sponsor will select potential winner in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. You must be present at the time of the drawing (8:00 pm) to win. The Sponsor will attempt to notify the potential winner on the premise on October 5 2018. If the potential winner cannot be contacted at the event within 5 minutes of calling his/her ticket number, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

### Winner Notification

The winner will be notified the day of the event, October 5th 2018. Each potential Prize winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, sign and submit a Declaration of Compliance the day of the event, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period (if applicable), potential winner forfeits prize. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorneys fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.
